



## COMBATING MEDICAL HOMELESSNESS: WHAT IS THE ROLE FOR ACADEMIC MEDICINE?

**Robert Berenson**, M.D., is a senior fellow in the Urban Institute's Health Policy Center. From 1998 to 2000, he was in charge of Medicare payment policy and managed care contracting at the Centers for Medicare and Medicaid Services. In the Carter administration, he served as an assistant director of the Domestic Policy Staff. An internist who practiced for 12 years in Washington, D.C., Berenson is an adjunct professor at the Fuqua School of Business at Duke University. He and Rick Mayes coauthored *Medicare Prospective Payment and the Shaping of U.S. Health Care*.

**Cristina Boccuti** is a senior analyst with the Medicare Payment Advisory Commission, which she joined in 2003, and has worked on issues related to physician payments, medical homes, hospices, and prescription drugs. Prior to joining MedPAC, she was a research associate in the Urban Institute's Health Policy Center. Boccuti also worked on Medicare payment issues at the Government Accountability Office and the U.S. Department of Health and Human Services. Before her career in health policy, she was a speech-language pathologist treating Medicare and Medicaid patients in a Chicago teaching hospital.

**Darrell Kirch**, M.D., became president and CEO of the Association of American Medical Colleges in 2006 after serving for six years as senior vice president for health affairs, dean of the college of medicine, and CEO of the Milton S. Hershey Medical Center at The Pennsylvania State University. Before joining Penn State, Kirch was dean and senior vice president for clinical activities at the Medical College of Georgia from 1994 to 2000. A psychiatrist and clinical neuroscientist by training, Kirch began his career at the National Institute of Mental Health, becoming the acting scientific director of the institute in 1993.

**J. Lloyd Michener**, M.D., is a clinical professor and chair of the Department of Community and Family Medicine at Duke University Medical Center. A member of the Duke faculty since 1982, Michener has played a central role in training university faculty, most particularly via a graduate health sciences program in clinical leadership. Beyond DUMC, Michener's work is dedicated to changing the three behaviors that cause 80 percent of all chronic disease in the United States: physical inactivity, poor nutrition, and smoking. Toward that end, he oversees the Obesity/Chronic Disease Prevention Program of the Kate B. Reynolds Trust, a program focused on helping low-income areas across North Carolina.

**Robert Reischauer** (moderator) is president of the Urban Institute. Before being appointed to this position in 2000, he was a senior fellow in economic studies at the Brookings Institution for five years. He served as director of the Congressional Budget Office from 1989 to 1995. Earlier posts include senior vice president at the Urban Institute and assistant director for human resources and deputy director at CBO. He is a member and former vice chair of the Medicare Payment Advisory Commission and was chair of the National Academy of Social Insurance's Restructuring Medicare for the Long Term project.
