Stacey McMorrow is a health economist who uses quantitative analysis to examine the factors that affect individual health insurance coverage and access to care as well as the impacts of state and national health reforms on low-income populations. She has contributed to several large-scale evaluation efforts including the Congressionally mandated evaluation of the Children's Health Insurance Program (CHIP), the national evaluation of the CHIP Reauthorization Act's Quality Demostrations, and a multi-year Urban Institute evaluation of the impacts of the Affordable Care Act (ACA). Most recently, McMorrow has developed a research agenda related to women's health and access to preventive and reproductive health services.
